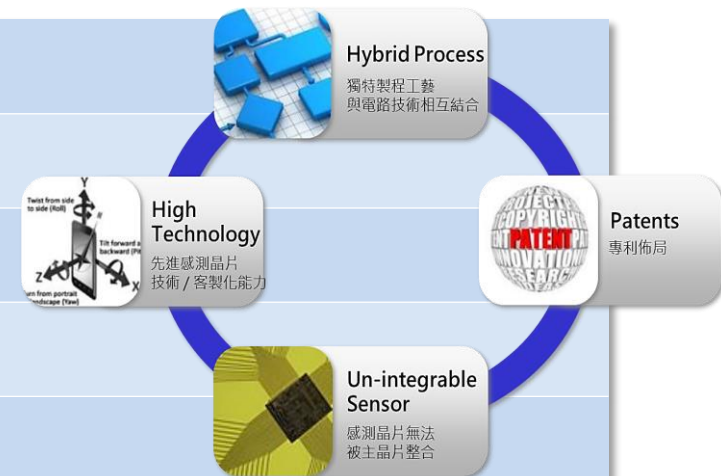

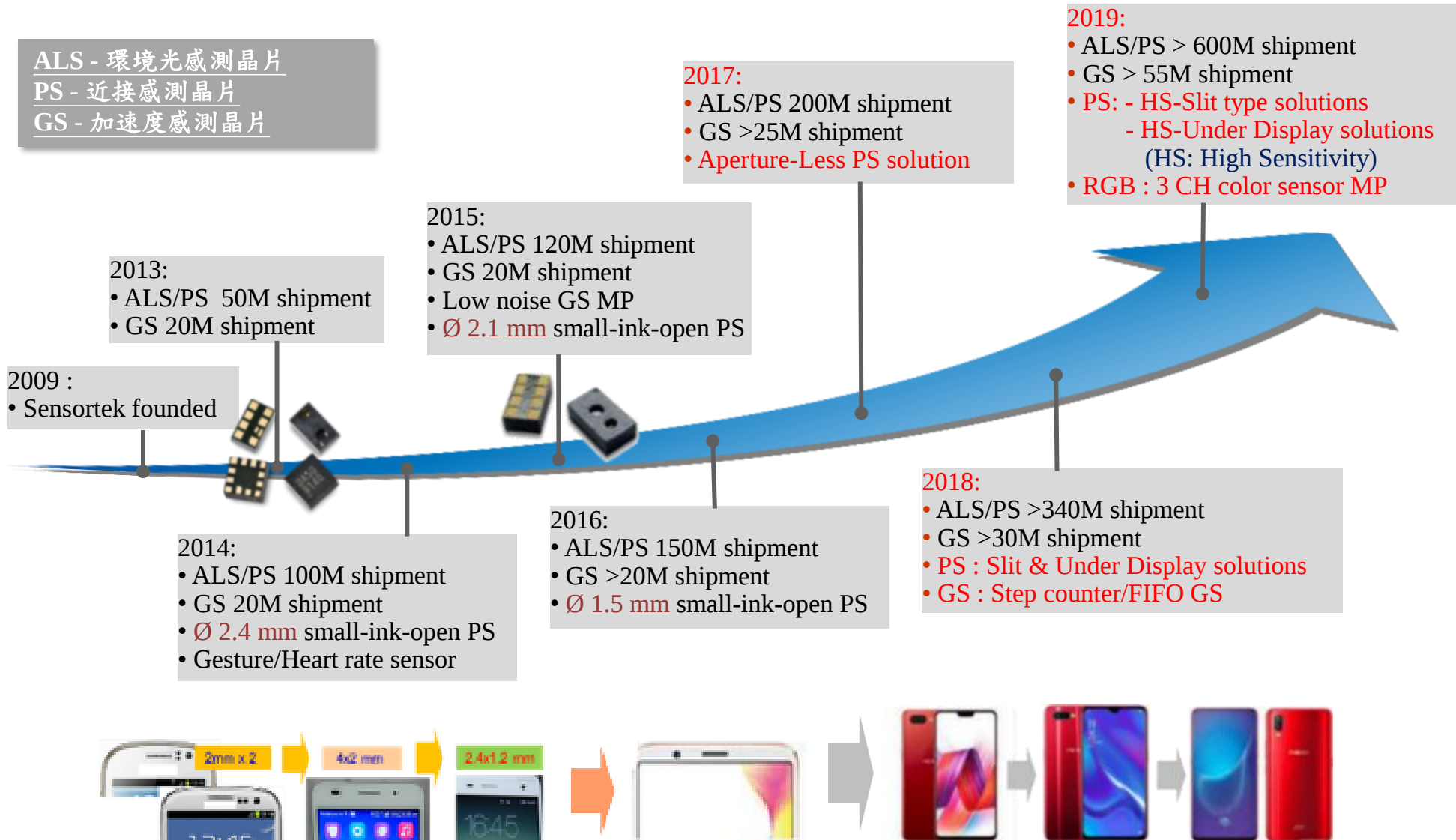

- G3. PS (w/T) + **RGB** sensors (**visible** sensor hole solution) **→ invisible solution (G4)**

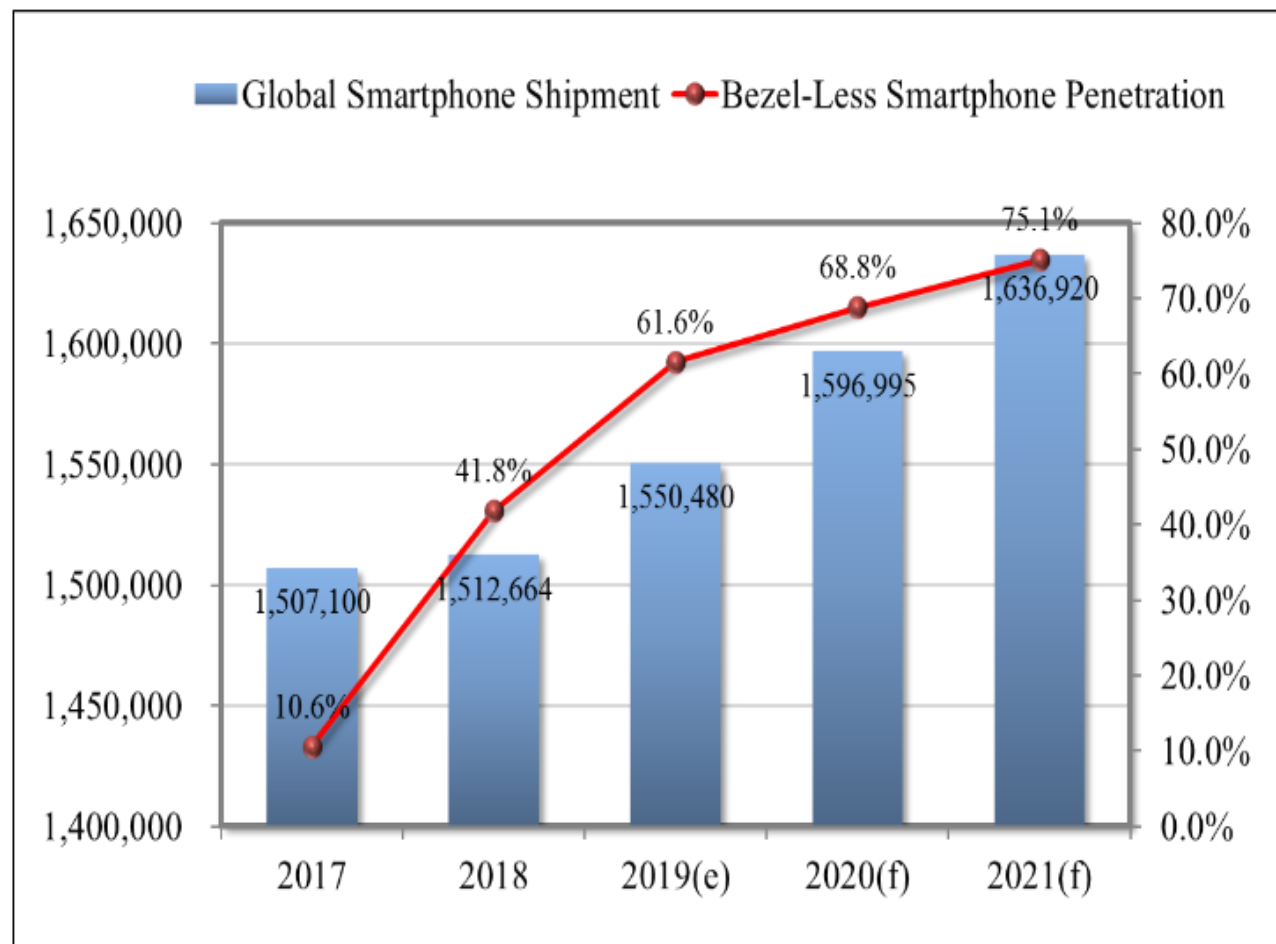

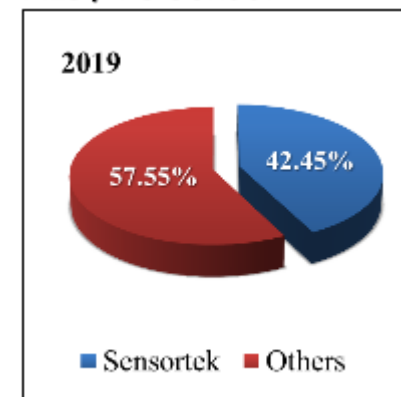
Smartphone Market Scale & Trends



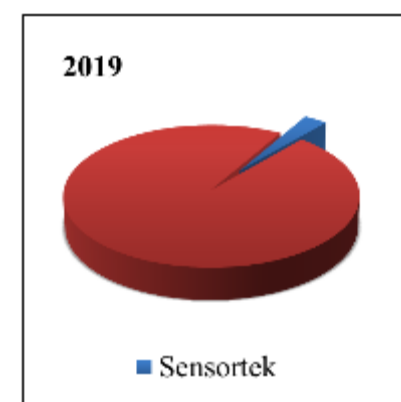

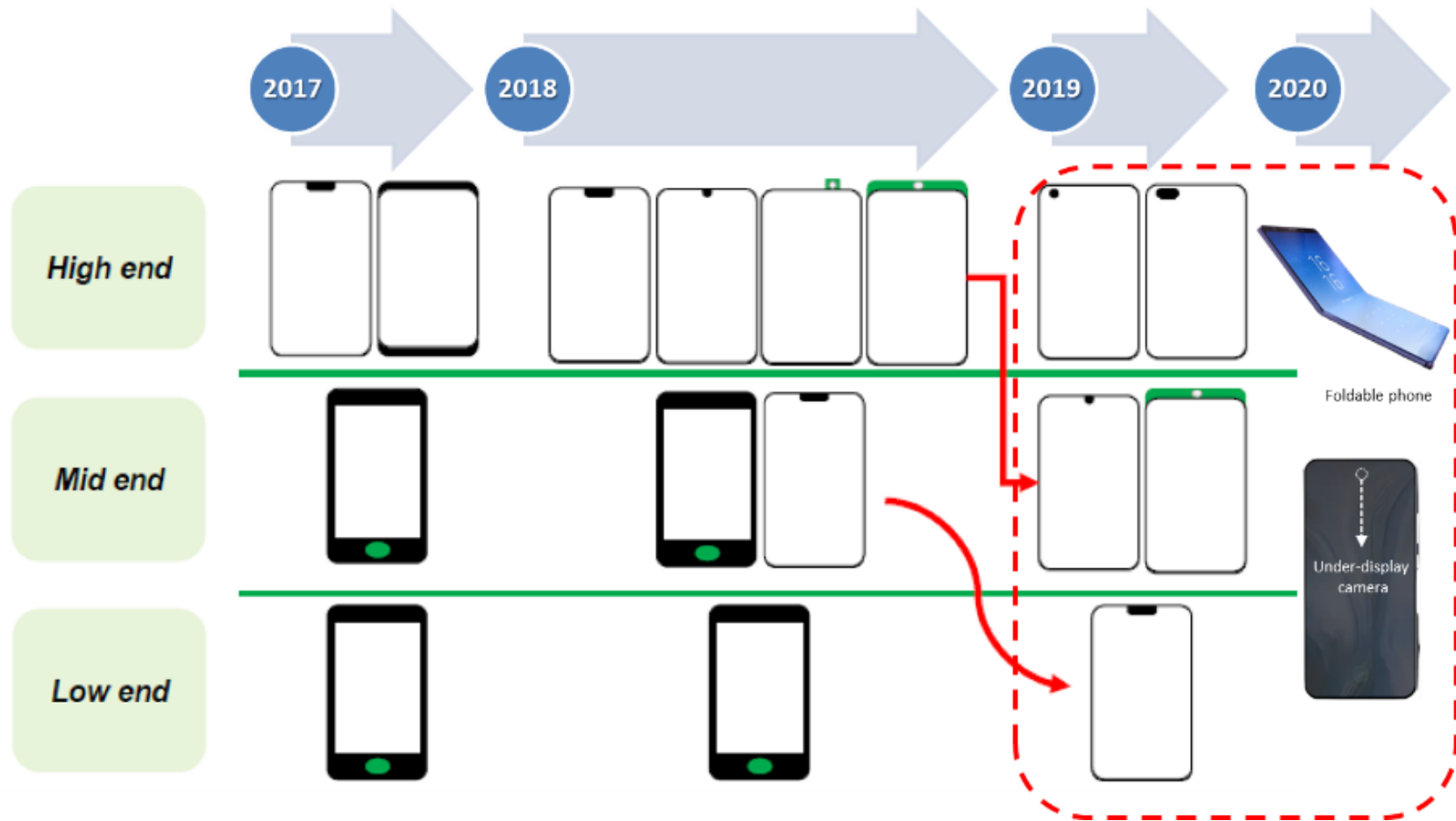

Bezel-less display trend in Smartphones

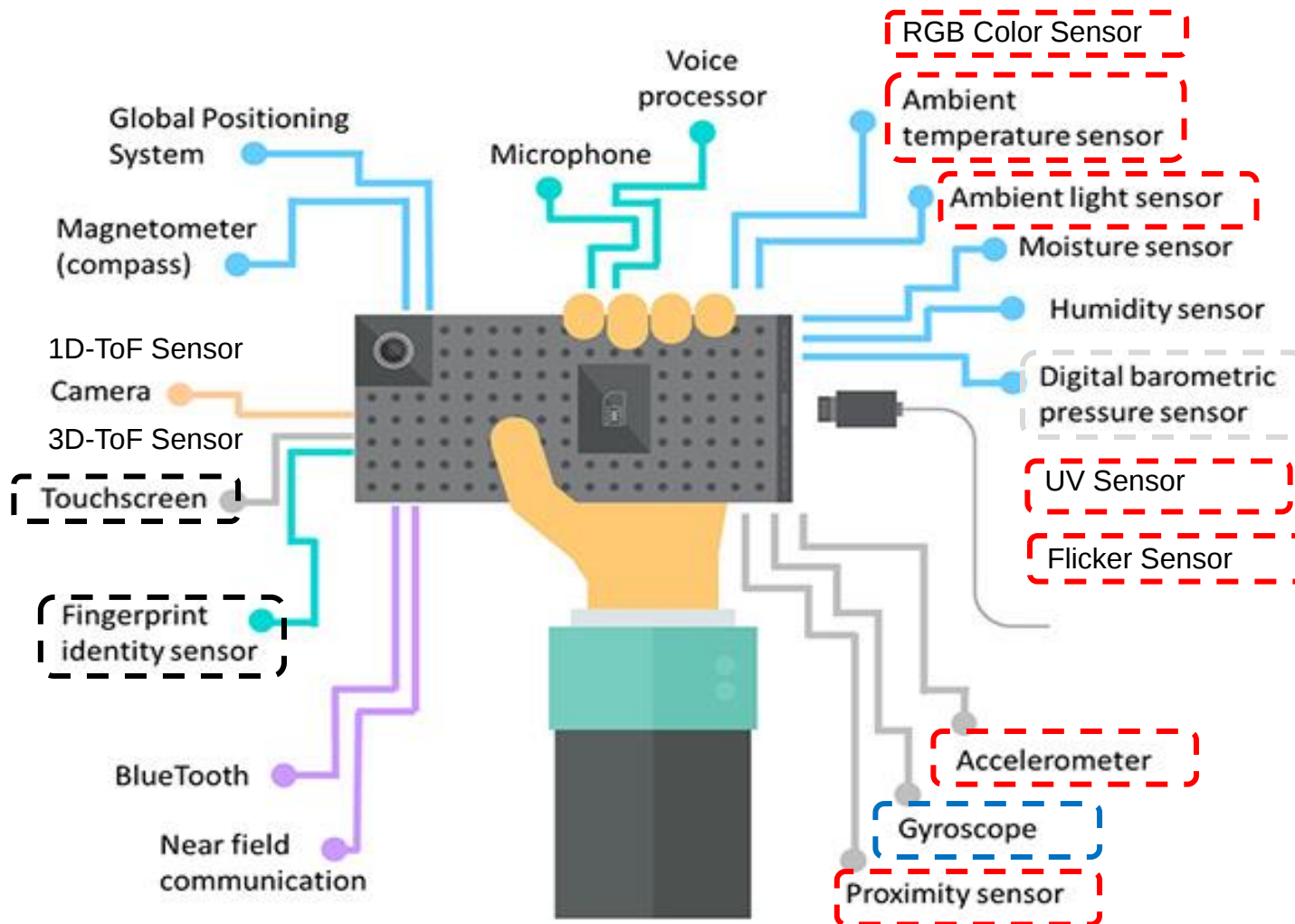


V. Future Development

Farther R&D & market planning

1. PS + ALS for smartphone displays → 協同前螢幕之應用
 - ❑ Under-display : PS (x3 屏下方案) + ALS → for AMOLED displays
 - ❑ Slit type : PS (x3 狹縫方案) + ALS → for TFT displays
 - ❑ HS_PS+ALS (x6 or x10 超高感度屏下方案) → for AMOLED display
 - ❑ PS+RGB sensors (色溫偵測/color temperature detection) → for flagship application
2. Optical sensors for rear cameras → 輔助後相機之應用
 - ❑ RGB sensor (白平衡校正/white balance correction)
 - ❑ flicker sensors (閃頻偵測/flicker detection)
 - ❑ RGB + flicker sensors
3. Speeding up MEMS development → 加速MEMS產品線
 - ❑ Gyroscopes (under development)
 - ❑ Accelerometers + Gyroscopes (2 in 1) → for high-end smartphones
4. Extend to other applications → 拓展其他非手機之應用
 - ❑ TWS : P sensor / Accelerometers
 - ❑ Smart watch : **ALS+UV** / Heartbeat sensor / Accelerometers
 - ❑ Smart speaker : ALS ...
